### CLASS 3 - limited to : 2.62%

Eye products of all types (eye shadow, mascara, eyeliner, eye make-up, eye masks, eye pillows, etc.) including eye care and moisturizer  
Facial make up and foundation  
Make-up remover for face and eyes  
Nose pore strips  
Wipes or refreshing tissues for face, neck, hands, body

### CLASS 4 - limited to : 31.25%
