Document written to communicate information throughout the supply chain, for a substance for which no safety data sheet is required.

(Document written according to article 32 of the REACH Regulation)

Relevant identified uses of the substance or mixture and uses advised against:

Relevant identified uses: food additive, adjuvant in wine process, cosmetic and pharmaceutical applications, formulation of fertilizers in agriculture, laboratory reagent, technical applications in manufacturing of metal products. Industrial, professional, domestic use.

Uses advised against: When writing this document, no other uses are known, unless an evaluation has been carried out before the start of that use, to demonstrate that risks deriving from that use are controlled and the substance is used in such a way that it does not damage human health or the environment.

Appearance and colour: crystalline white powder

On the basis of the available information, the substance of interest does not meet the criteria for classification as dangerous, according to CLP (CE) Regulation n. 1272/2008. It is not persistent, bio-accumulative and toxic and it is not very persistent and accumulative, on the basis of the criteria set out in Annex XII of the REACH Regulation. It is also not included in the list established in accordance with article 59.1 (of the REACH Regulation), for different reasons from the ones set out under letters a) and b).

No safety data sheet is therefore required, but only transmission of some information, down the supply chain, for the downstream user:

1. Registration number of the substance: 01-2119982996-11-0000
2. Substance not subject to authorisation
3. Substance not subject to restrictions in compliance with Annex XVII of the REACH Regulation
4. Information for a safe use of the substance: Based on knowledge, no special precautions for use are to be taken: given that the substance is supplied in powder form, we suggest to use a powder mask when handling it in bulk. When supplied to the food industry, the product shall be used following the hygienic regulations provided for this specific sector. In case of fire, any extinguishing means can be used. Protection equipment is to be used in case of an extended fire. No special storage precautions are required. Store in closed containers away from humidity. The substance and its container are classified as non dangerous special wastes. Make a classification according to the Legislative Decree 152/2006.
